

Washington Academy Chromebook Agreement

Information and Procedures

2020-2021 Chromebook

Page two must be completed and submitted before receiving a Chromebook for the year.

Ownership of the Chromebook

The Chromebook remains the property of Washington Academy (WA) at all times. Students have no expectation of confidentiality or privacy in regards to the usage of the Chromebook. WA may, without notice or consent, log, supervise, access, view, monitor, and/or record use of student Chromebooks at any time.

Receiving Your Chromebook

All students before receiving their Chromebook must sign and submit Washington Academy's Student Chromebook Agreement form.

Students will be issued their Chromebook, carrying case, and charger at the start of the 2020-2021 school year and all will be returned at the end of the school year. Failure to return the Chromebook will result in the student being charged \$250 (\$215 computer, \$15 power adapter, \$20 protective carrying case). WA may also file a report of stolen property with local law enforcement agencies at that time.

Care of Your Chromebook

Students are responsible for the general care of the Chromebook and peripherals. Chromebooks that are broken or fail to work properly must be taken to the Technology Director as soon as possible. Temporary replacements may be available on a first come first serve basis. In either case, students are responsible for any physical damage or loss of a Chromebook, case, or charger.

General Precautions, Expectations, and Use

Washington Academy believes that the internet is a crucial component of the educational program for our learning community. WA has opted to use Chromebooks as a conduit to the internet for our students. The listed general precautions and expectations are a guide and are not limited in nature. Common sense in the care, handling, and use of a Chromebook is key. Students will be charged up to the full amount of \$250 (\$215 computer, \$15 power adapter, \$20 protective carrying case) for any accidental or intentional physical breakage.

- Sound must be muted at all times unless permission is obtained from a teacher. For sanitary reasons, students should have their own personal set of headphones.
- Chromebooks when not in your possession may be placed in locked lockers only.
- You will be responsible for spill damage! Be careful with food and/or drinks next to a Chromebook.
- Cords, cables, and removable devices must be inserted carefully into the Chromebooks.
- Chromebook power cords should not create a tripping hazard.
- Chromebooks are to be taken to every class and be fully charged daily unless specifically advised not to do so by their teacher.

- Protective cases are provided for each device and students are expected to use the case for transportation and when the device is not in use. Although the cases are protective in nature, they are not guaranteed to prevent damage. At all times, it is the student’s responsibility to protect their Chromebook.
- Chromebooks may NOT have writing or adhesive stickers on them.
- School appropriate non-adhesive skins, keyboard protectors, and cases ARE allowed.
- Never lift or carry the Chromebook by the screen.
- Pressure or heavy objects should never be placed on top of the Chromebook.
- Make sure there is nothing on the keyboard before closing the lid.
- Students are expected to use the Chromebook, charger, and carrying case assigned to them. Do not borrow (or lend to) others.
- The majority of student work will be stored on the internet/cloud making it accessible from multiple platforms/devices. Washington Academy will NOT be responsible for the loss of any student work. Students are encouraged to actively make backups of important work with alternative internet storage solutions or on removable media devices.
